Need funding for unexpected building expenses? Lovington MainStreet & Lovington Chamber of Commerce have joined to bring a new funding opportunity for MainStreet Businesses or Chamber members.

The COVID-19 Pandemic has hindered our local businesses' ability to resolve unexpected emergencies, that we know happen regardless of the current situation. We're here to offer some small financial relief. From May 1st through August 30th, businesses affected from the economic crisis that has affected all of us, are encouraged to apply for a one-time grant of up to \$1000 for emergency repairs and expenditures. This contingency fund will be administered on a first-come, first-serve basis, until funds are depleted. A committee will designate funding and receipts, with contacts must be provided.
